HOW IT WORKS



Each course takes about 90 minutes to complete with a 30-question multiple choice quiz at the end.

Students are granted access to the online course, which can be completed at any time, 24/7.

Once they have completed their test, their onsite manager will conduct their evaluation.

Once Big Joe receives the completed evaluation sheet, the students certification card will be issued.

FREQUENTLY ASKED QUESTIONS:

Is the training available in Spanish?

Yes, english and spanish is available for all classes. The student has the option to switch between english and spanish at any time during the class.

How long is the class?

Each class takes about 90 minutes to complete. If the student is signed up for more than one type of equipment, each class will take 90 minutes with a separate 30-question multiple-choice test at the end.

Is regular onsite classroom training still available?

Yes, we are not getting rid of regular operator onsite training. This is just an additional option for your convenience. It is especially convenient for those who are looking to get recertified.

Is Train-the-Trainer available online?

No, we are not offering "Train the Trainer" online at this time. That must be done in-person either onsite at your facility, or in our classroom.

Do you have to come onsite to complete the training?

Your company can have your supervisor of the employee training conduct their evaluation. We will provide the evaluation form for you to use. If you do not have a qualified individual to conduct the evaluation, we will conduct it onsite for you. Travel fees may apply.
